INTRODUCTION

To comply with State and Federal regulations, the Village and Town of Little Valley will be issuing a report annually describing the quality of your drinking water. The purpose of this report is to raise your understanding of drinking water and awareness of the need to protect our drinking water resources. Last year, your tap water met all State drinking water health standards. We are proud to report that our system did not violate a maximum contaminant level or any other water quality standard. This report provides an overview of last year's water quality. Included are details about where your water comes from, what it contains, and how it compares to State standards.

WHERE DOES OUR WATER COME FROM?

In general, the sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activities. Contaminants that may be present in source water include: microbial contaminants; inorganic contaminants; pesticides and herbicides; organic chemical contaminants; and radioactive contaminants. In order to ensure that tap water is safe to drink, the State and the EPA prescribe regulations which limit the amount of certain contaminants in water provided by public water systems. The State Health Department's and the FDA's regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Our water system serves approximately 1,188 people through 545 service connections in the Village and approximately 150 people through 50 service connections in the Town District. Our water source currently consists of two wells located on Tenth Street in the Village. The wells are 76 feet deep and 190 feet. Both wells draw from a local unnamed aquifer at approximately 90 feet below the surface and can produce a total of 440 gallons per minute. This water is treated by the addition of liquid chlorine and sodium fluoride prior to distribution.

In 2003, the NYS DOH completed a source water assessment for our water system, based on available information. Possible and actual threats to the drinking water sources were evaluated. The source water assessment includes a susceptibility rating based on the risk posed by each potential source of contamination and how easily contaminants can move through the subsurface to the wells and springs. The susceptibility rating is an estimate of the potential contamination of the source water. It does not mean that the water delivered to consumers is, or will become contaminated. The source water assessments provide resource managers with additional information for protecting source waters into the future.

As was mentioned before, our water is derived from two wells. The source water assessment has rated combined susceptibility to contamination for the wells as high from enteric viruses and medium high from enteric bacteria, halogenated solvents, herbicides/pesticides, metals, nitrates, other industrial organics, petroleum products, and protozoa. The elevated ratings for the wells are due to the characteristics of the aquifer. No significant sources of contamination were identified for the wells. Please note that our water is disinfected to ensure that the finished water delivered into your home meets New York State's drinking water standards for microbial contamination.

ARE THERE CONTAMINANTS IN OUR DRINKING WATER?

As the State regulations require, we routinely test your drinking water for numerous contaminants. These contaminants include: coliform bacteria, inorganic compounds, volatile organic compounds, nitrate, lead and copper, total trihalomethanes, haloacetic acids, and radiological compounds. In addition, we test for chlorine and fluoride daily. The table presented below depicts the contaminants that were detected in your drinking water. The State allows us to test for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data, though representative, are more than one year old.

It should be noted that all drinking water, including bottled water, might be reasonably expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. - The level presented represents the 90th percentile of the 10 sites tested. A percentile is a value on a scale of 100 that indicates the percent of a distribution that is equal to or below it. The 90th percentile is equal to or greater than 90% of the copper values detected at your water system. In this case, ten samples were collected at your water system and the 90th percentile value was the second highest value, 84 ug/l. The action level for copper was not exceeded at any of the sites tested.
 - The 90th percentile level for lead was 1.4 ug/l. None of the sites exceeded the action level of 15 ug/l.

Definitions:

- Action Level (AL):** The concentration of a contaminant, which, if exceeded, triggers treatment or other requirements, which a water system must follow.
- Maximum Contaminant Level (MCL):** The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible.
- Maximum Contaminant Level Goal (MCLG):** The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- Maximum Residual Disinfectant Level (MRDL):** The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- Maximum Residual Disinfectant Level Goal (MRDLG):** The level of drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contamination.
- Micrograms per liter (ug/l):** Corresponds to one part of liquid in one billion parts of liquid (parts per billion - ppb).
- Milligrams per liter (mg/l):** Corresponds to one part of liquid in one million parts of liquid (parts per million - ppm).
- Not Detected (ND):** Laboratory analysis indicates that the constituent was not present.

WHAT DOES THIS INFORMATION MEAN?

As you can see by the table, our system had no violations. We have learned through our testing that some contaminants have been detected; however, these contaminants were detected at values well below the level allowed by the State. Regardless, we are required to provide the following standard information on lead in drinking water.

Lead can cause serious health effects in people of all ages, especially pregnant people, infants (both formula-fed and breastfed), and young children. Lead in drinking water is primarily from materials and parts used in service lines and in home plumbing. The Village of Little Valley is responsible for providing high quality drinking water and removing lead pipes but cannot control the variety of materials used in the plumbing in your home. You can help protect yourself and your family by identifying and removing lead materials within your home plumbing and take steps to reduce your family's risk. Using a filter, certified by an American National Standards Institute accredited certifier to reduce lead, is effective in reducing lead exposures. Follow the instructions provided with the filter to ensure the filter is used properly. Use only cold water for drinking, cooking, and making baby formula. Boiling water does not remove lead from water. Before using tap water for drinking, cooking, and making baby formula, flush your pipes for several minutes. You can do this by running your tap, taking a shower, doing laundry or a load of dishes. If you have a lead service line or a galvanized requiring replacement service line, you may need to flush your pipes for a longer period. IS OUR WATER SYSTEM MEETING OTHER RULES THAT GOVERN OPERATIONS?

On March 2, 2022, the CCHD conducted a sanitary survey of our water system. One deficiency that was noted is the lack of a secondary well source that has enough capacity and could guarantee continued delivery of water in the event that the primary well failed.

We presently do utilize a second well but it cannot produce enough water by itself to meet the daily demand. Therefore, we need to develop a 3rd source of water in order to be able to meet maximum daily demand if the need arises. A second deficiency noted was that well #3 is located in a well house below the flood plain.

We are working with the CCHD to ensure that the required corrective action is being taken in the very near future. Barton and Loguidice, D.P.C. has been hired to engineer the needed capital improvements. We have secured funding through several grants, and have already began developing an additional well. The next steps will be in building a new treatment building out of the flood plain, and connecting the well sources to this treatment building. Projected start date on the new Treatment Building will be Summer 2025. We have completed all of the Water Main and Service Line installation for our Water Line Replacement planned at this time.

INFORMATION ON LEAD SERVICE LINE INVENTORY

A Lead Service Line (LSL) is defined as any portion of pipe that is made of lead which connects the water main to the building inlet. An LSL may be owned by the water system, owned by the property owner, or both. The inventory includes both potable and non-potable SLs within a system. In accordance with the federal Lead and Copper Rule Revisions (LCRR) our system has prepared a lead service line inventory and have made it publicly accessible by posting at the Little Valley Village Clerk's Office at 201 Third Street, Little Valley, NY 14755 or visiting our website at: <https://health.data.ny.gov>.

DO I NEED TO TAKE SPECIAL PRECAUTIONS?

Although our drinking water met or exceeded state and federal regulations, some people may be more vulnerable to disease causing microorganisms or pathogens in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice from their health care provider about their drinking water. INFORMATION ON FLUORIDE ADDITION

Our system is one of the many drinking water systems in New York State that provides drinking water with a controlled, low level of fluoride for consumer dental health protection. According to the United States Centers for Disease Control, fluoride is very effective in preventing cavities when present in drinking water at a properly controlled level.

In accordance with NYSDOH regulations, we monitor fluoride levels on a daily basis to make sure fluoride which is recommended to be maintained at a target level of 1.0 mg/l. *However, we do not operate our fluoride addition at the recommended levels for dental protection and its effectiveness is likely compromised as a result. The average daily fluoride level in our drinking water was .031 mg/l.* None of the monitoring results showed fluoride at levels that approach the 2.2 mg/l MCL for fluoride.

WHY SAVE WATER AND HOW TO AVOID WASTING IT?

Although our system has an adequate amount of water to meet present and future demands, there are a number of reasons why it is important to conserve water:

- ◆ Saving water saves energy and some of the costs associated with both of these necessities of life;
- ◆ Saving water reduces the cost of energy required to pump water and the need to construct costly new wells, pumping systems and water towers; and
- ◆ Saving water lessens the strain on the water system during a dry spell or drought and helps to avoid severe water use restrictions, so that essential fire fighting needs are met.

You can play a role in conserving water by becoming conscious of the amount of water your household is using, and by looking for ways to use less whenever you can. It is not hard to conserve water. Conservation tips include:

- ◆ Automatic dishwashers use 15 gallons for every cycle, regardless of how many dishes are loaded. So get a run for your money and load it to capacity.
- ◆ Turn off the tap when brushing your teeth.
- ◆ Check every faucet in your home for leaks. Just a slow drip can waste 15 to 20 gallons a day. Fix it up and you can save almost 6,000 gallons per year.
- ◆ Check your toilets for leaks by putting a few drops of food coloring in the tank. Watch for a few minutes to see if the color shows up in the bowl. It is not uncommon to lose up to 100 gallons a day from one of these otherwise invisible toilet leaks. Fix it and you save more than 30,000 gallons a year.
- ◆ Use your water meter to detect hidden leaks. Simply turn off all taps and water using appliances. Then check the meter after 15 minutes. If it moved, you have a leak.

CLOSING
